**MISSION**


To support and defend the U.S. Constitution, protect and safeguard all life, and ensure the equal protection of rights for all as we work to reduce both crime and fear of crime.

Under this form of policing, officers are assigned to specific beats or neighborhoods, where they actively work to build positive relationships with the residents of that area. # ACCPD Good News




Whether it is our own Citizen Police Academy or a visit from other adult or youth programs, the interaction between citizens and our department is essential to our community policing efforts.





# Operational Support Bureau






# Administrative Services Bureau



While the public sees ACCPD officers daily, these employees work behind the scenes to ensure the successful operation of the department. This bureau provides uniforms, essential training, computer support, and recruitment as well as supporting the department with evidence technicians and communications officers.





An ACCPD investigation led to the recovery of a stolen firearm and the seizure of unspecified amounts of cocaine, heroin, and methamphetamine. Our Community-Oriented Policing Unit also seized several other firearms and an unspecified amount of U.S. currency.



Long-time volunteer coordinator Mary Hamby was honored at a luncheon for her service to the department. Mayor Kelly Girtz proclaimed April 21, 2021, Mary Hamby Appreciation Day.

A Little Free Library was installed by volunteers in the front parking lot of ACCPD's East Precinct on Lexington Road.




# Trunk OR Treat 2021

# Jerry B. NeSmith Behavioral Health Co-Responder Unit

The Jerry B. NeSmith Behavioral Health Co-Responder Unit is a collaborative effort to address mental health issues related to police activity in Athens-Clarke County.

The unit was named for former Athens-Clarke County Commissioner Jerry NeSmith, who passed away in June 2020, and was a strong advocate for the creation of ACCPD's behavioral health unit.

The unit's three teams are comprised of one ACCPD officer and a mental health clinician from Advantage Behavioral Health Systems. The teams teach Crisis Intervention to all ACCPD officers to assist them when responding to calls with mental health connections. If necessary, an officer can request a Crisis Intervention Team to help an individual in crisis. Over the last five years, calls with mental health connections have mainly increased.





# Office of Professional Standards

The mission of the Office of Professional Standards is to promote public trust in and effective management of the department and its personnel through a rigorous review and oversight process. This is accomplished through a systematic review of high-risk activities such as the use of force and vehicle pursuits, as well as investigation of specific allegations of wrongdoing by the department or its employees.


It is the policy of the department to objectively investigate all allegations of wrongdoing objectively and thoroughly and fairly administer discipline when appropriate. This office also promotes transparency and accountability as a conduit for information between the police department, other ACC agencies, the Manager’s Office, and the Commission in response to requests and inquiries from the public.

Beyond reviewing specific incidents, Professional Standards conducts annual reviews of departmental activities to identify any trends, patterns, or areas of concern related to the use of force, vehicle pursuits, complaints, discipline, and more.

In 2021, the Office of Professional Standards reported 96,380 citizen contacts with the ACCPD. Additional data in the table shows that 3.2% of encounters led to arrests, and only .12% or 111 encounters led to Use-of-Force incidents. Of the 96,380 contacts, ACCPD received 27 complaints, approximately .03%. Using the 2021 *Disciplinary Actions* chart on the facing page, only one complaint resulted in disciplinary action.

\*In 2019, there were only six incidents in which officers used deadly force. The data above reflects the total number of officers who used lethal force. The Georgia Bureau of Investigation independently reviewed these 2019 Use-of-Force incidents. The results were forwarded to the Clarke County District Attorney for final consideration. The district attorney determined that all deadly force incidents were legally justified.

# Crime Report

## Athens-Clarke County Overall Crime Rate Decreased 4.6% in 2021



While detectives may work behind the scenes and are not seen as often as uniform patrol officers, they play a major role in solving crimes by analyzing evidence, obtaining search warrants, and interviewing witnesses.


The 2021 overall crime rate measured 35.3 crimes per 1,000 residents, representing a 4.6% decrease from 2020's crime rate of 37.0.

The total number of reported select Group "A" offenses fell from 4,782 in 2020 to 4,617 in 2021.

Select Group "A" Offenses that have been historically used to determine the crime rate are Murder, Rape, Aggravated Assault, Robbery, Burglary, Larceny, and Motor Vehicle Theft.


## Athens-Clarke County Population with ACC Crime Rate-10 Year Range



The crime rate is intended to serve as a basic indicator of overall crime trends and is a commonly accepted law enforcement measurement. It is based on seven Group "A" offenses and is not a comprehensive tracker of all crimes.

## Four Murders in 2021 - Three of Four Closed After Investigation

*One closed by adult arrest - One closed by juvenile arrest - One closed by self-defense*



Murder is often considered the highest profile crime committed against a person and is defined as a willful killing of one human being by another. The classification of this offense is based solely on police investigation as opposed to the determination of a court, medical examiner, coroner, or jury.

From 2020 to 2021, the number of murders decreased by one, from five to four. This classification does not include deaths caused by negligence, suicide, accidents, or justifiable homicides.

# Crime Report



## All Crime Summary

The overall number of crime incidents decreased by 5.0% from 2020. In 2020, there were 11,630 incidents versus 11,050 in 2021. Crimes Against Persons, Crimes Against Property, and Crimes Against Society were all down from 2020 statistics.




# In Memory of Our Fallen



**Senior Police Officer Elmer Basco "Buddy" Christian, III**  
**Athens-Clarke County Police Department**  
**End of Watch: March 22, 2011**

Senior Police Officer Buddy Christian was shot and killed while responding to an incident where another officer had been shot and wounded at an apartment complex on Sycamore Drive in Athens. Multiple officers were investigating a carjacking and kidnapping incident when one officer stopped a vehicle owned by a relative of the carjacking suspect. The suspect exited the vehicle and shot and wounded the officer twice before fleeing on foot.

Officer Christian had just responded to the area when he encountered the suspect. The man shot and killed Officer Christian through the window of his patrol vehicle. He then fled the scene and remained at large until being apprehended three days later.

On July 27th, 2015, the 37-year-old suspect was sentenced to life in prison without the possibility of parole.

Senior Police Officer Christian is survived by his wife, two children, parents, and a brother.


**Police Officer Donald Moon**  
**Athens Police Department**  
**End of Watch: November 3, 1963**

Police Officer Donald Moon was shot and killed by a 15-year-old juvenile seeking revenge against him. Officer Moon was off duty and teaching his girlfriend how to drive when the subject approached them and opened fire without warning.

The suspect was convicted of first-degree murder and sentenced to life. He died in prison on June 5, 2000.

Officer Moon had served with the Athens Police Department for only 19 months. Hired along with his cousin, they were Athens' first black police officers. Officer Moon was a Korean War Veteran.

One child survived Officer Moon.



**Corporal Thomas Earl Bowles**  
**Athens Police Department**  
**End of Watch: January 16, 1985**

Corporal Thomas Bowles died as a result of a cerebral hemorrhage that he suffered after being assaulted four days earlier. He was attempting to arrest a man for DUI when the man resisted and struck Corporal Bowles in the head.

Despite his injuries, Corporal Bowles was able to place the man under arrest and started driving him to the jail. During the drive, Corporal Bowles began experiencing chest and head pains. He radioed for medical assistance and backup.

He was transported to a local hospital and lapsed into a coma. Corporal Bowles remained in the coma until his death four days later.

Corporal Bowles served with the Athens Police Department for 20 years. His wife and three children survived him.

**Police Officer Herman Karl Stein**  
**Athens Police Department**  
**End of Watch: November 29, 1936**


Officer Stein was shot and killed after responding to a business where a robbery was in progress. When Officer Stein arrived at the scene, the suspect fled.

Officer Stein caught the suspect, and a struggle ensued. The suspect gained control of Officer Stein's gun and shot him in the head.

The suspect was apprehended two days later near Lula, Georgia. He was convicted of murder and executed in the electric chair on December 27, 1937.

Officer Stein served with the Athens Police Department for five years. His wife and three children survived him.
